

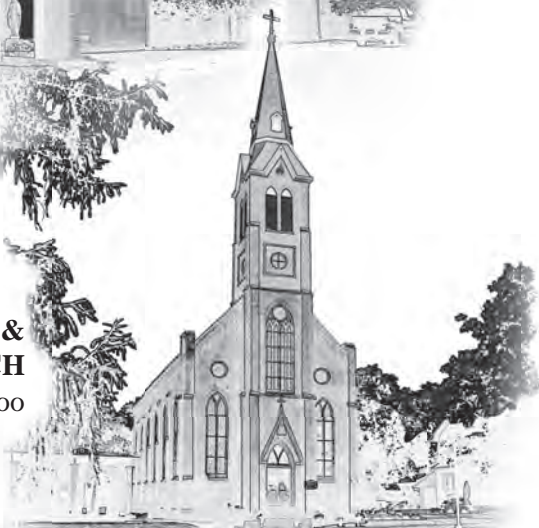

As Convention and Election Days Draw Near.

You're going to be presented with selections from the Catechism of the Catholic Church - call the Catechism, "The Codification and Application of Sacred Scripture and Tradition" - and call Tradition, "The lived experience of the Scriptures, and the direction of sacred teaching generated from that experience" - as we draw nearer to political convention and election days in our nation. At a time when neither major political party is much help to church teaching, either in terms of presenting their public platforms or hiding behind them, it's fitting that we present Church teaching without compromise, and that we can identify that it is Church teaching to which we are listening, or about which we are reading. These selections will be unvarnished quotes, no editorial comment. "We preach Jesus Christ, and Him crucified," says St. Paul. In the current day, we don't want people figuring whether any preacher is Republican or Democrat; we want people to know what the teaching of the Catholic Church is. We'll start with the "Big Three": abortion, because it destroys the foundation of civilization; sins against the truth of the human body, because they destroy marriage and family; and excessive debt, which, for any nation, is a crime against the poor. All, according to the Catholic Church's teaching.
