And Now For the Next Phase: Growing Disciples Advances.

I don't think there will ever be anything easily accepted about the "Relegated to 'No Longer in Use'" designation given to our Dallas City and Hamilton Churches. I understand all too well the "Rip off the Band-Aid" approach to closures: do it fast and get it over with. I can't, and won't, criticize it. But I guess my personal investment in all of our churches leads me to the example of a loved one in bed as the end of life runs its course. Imagine me, or anyone, thinking, "They're going to be gone, anyway; so why not just put a pillow over his face and get it over with?" That's why we're keeping everything the same until July 1, 2025; we're going to take time and allow things to run their course for a while. Not canonizing the point of view; just saying it's mine.

But after presenting future name and Mass schedule proposals to Bishop Tylka (still awaiting response at this time), it's time to enter into the more difficult aspects of implementing Growing Disciples. Pastoral Council, Finance Councils, Growing Disciples Committee, and SPPS Education Commission will be addressing: first, identification and prioritization of repair, maintenance, and renovation needs, under the current separate budgets of the three churches and school in our newly aligned parish; second, working toward a single uniform budget, according to the criteria set forth by Growing Disciples; and third, assessment of lay liturgical & pastoral ministries, as well as committee & service organizations structure: whether and how to combine them. Dallas City and Hamilton: the invitation to be involved in moving toward "No Longer In Use" designation is open to you, every step of the way. Patience, one and all: don't let the natural course of gossip lead you to jump to any conclusions - you will hear formal conclusions, in all clarity, from me. In the meantime, we welcome your thoughts, all along the way. Fr. T.

Jubilee Year 2025: Pilgrims of Hope. And: 150th Anniversary of the Peoria Diocese. Sts. Peter and Paul Church in Nauvoo is designated as a "Church of Pilgrimage," that is, a destination and location which, accompanied by prayer, Confession and Holy Communion, and good works, comprise a "journey of prayer" for a plenary indulgence.

As Pilgrims of Hope, God's "mercy & forgiveness", and "indulgence", come to mean the same thing: but by way of participation in how the Mystical Body of Christ actually purifies us from sin and its ongoing effects, after forgiveness.

"Indulgence" is what the Holy Trinity does from all eternity: mercy, generously and constantly poured out. The Mystical Body of Christ - the mystery of the Church of the saints in heaven, the "pilgrims of hope" on earth, and the souls in Purgatory - is the reality in which we participate in the indulgence of God to not only wipe away sin, but also to release the soul from the ongoing effects of sin, after sin is forgiven.

While we await further instructions about the Jubilee Year and the 150th Anniversary Celebration of the Peoria Diocese, let's consider the Baptism of the Lord as our own commitment to be Pilgrims of Hope, and partake of God's mercy and forgiveness for ourselves, and for the purification of the Mystical Body of Christ for the Church on earth and the souls in Purgatory.

We'll make it a point to carefully explain things, in the coming weeks. But for now: a great start would be to receive the grace offered to us: to be sorry for sins in a heartfelt way; to be determined to not even be attached or attracted to the mere thought of sin; to make a confession with the intent of preparing for the Indulgence; and to think about prayer, self-denial, and sharing of self in service to others, to enter fully into the power of the Holy Trinity to purify our souls.

Tony will make a pilgrimage of intercessory prayer for our Hancock County Catholic Churches at the sites of the California Mission Churches founded by St. Junipero Serra. Please be aware of these times during which Fr. Tony will not be present in the county.
