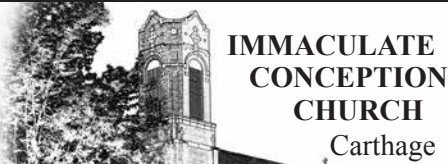


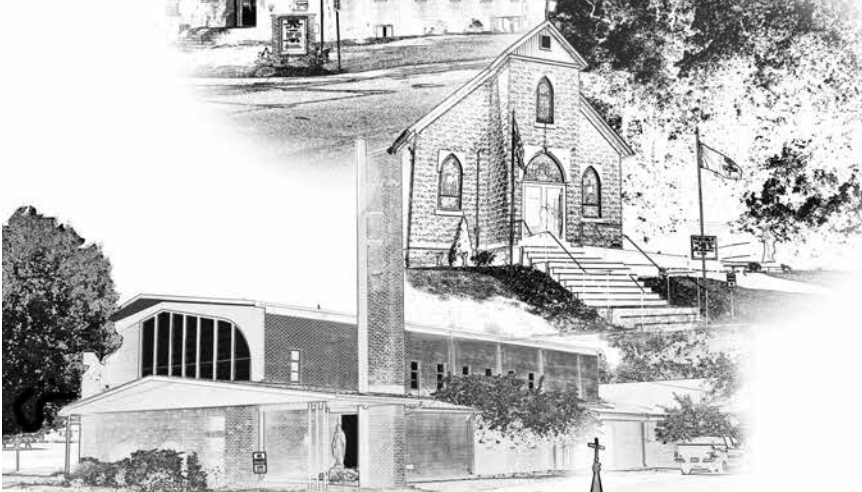

Jubilee Year: Pilgrims of Hope - Indulgences, Part IV.

One of the reasons we're a bit late on observing the Jubilee Year worldwide - and the 150th Anniversary of the Diocese of Peoria - is that we haven't received much guidance from Peoria yet. But we can tell you this much: Sts. Peter and Paul Church is designated a Church of Pilgrimage for our area. Therefore, if you pass through our Holy Door - the side entrance of Sts. Peter and Paul Church, Nauvoo - in conjunction with the practice of an Indulgence, then you have intentionally combined your indulgence with an intentional travel to a sanctuary of the Catholic Church. This travel as prayer is what we call a Pilgrimage.

Here are the conditions for an Indulgence:

1. You offer an indulgence only for yourself, or for the soul of one who has died. (Remember: in this life, time implies the exercise of free will, which we exercise for no one except ourselves. In the next life, in death - and therefore beyond time and the exercise of free will - souls rely on the purification going on in the Mystical Body of Christ.)
2. You are to offer an Apostles Creed, an Our Father, a Hail Mary, and a Glory Be for the intentions of Pope Francis. (He's the symbol of the Church's unity, and your unity with the Church's worship and teaching. With these prayers, you consciously, deliberately line yourself up within the One, Holy, Catholic, and Apostolic Church.)
3. You must be free from sin through the Sacrament of Penance (Confession); more than that, you must have an attitude of resistance to even the attraction of sin. Purity of soul, here!
4. You must participate in the Mass and receive Holy Communion. (Confession and Communion can take place within a week, either way, before or after the specific prayer, work of mercy, or activity accompanying the Indulgence.)
5. Your participation in an Indulgence can include: Adoration of the Blessed Sacrament; the Rosary or the Litanies; works of mercy; participation in the spiritual formation opportunities that will be provided, beginning with the season of Lent; prayer, fasting, and almsgiving to the poor; etc. We'll conclude with this explanation of Indulgences next week.

Do you want to build a snowman -or- Start an online BIBLE STUDY &/or PODCAST?! Happy New 2025 Year! Even though this has already started, all are welcome to join at any time!

FIRST, we will be using the new study, "Luke: The Story of Salvation Fulfilled". Online access is at **ascensionpress.com**. The total cost is \$7.37 per person and access is given for the study materials for one year. When paying for the study be sure to set up an account and not check out as a guest. After payment is confirmed you should see at your **ascensionpress.com/account** screen a tan button on the upper left side entitled "Study Dashboard". The study should be there soon if not immediately. There are eight sessions with the first session being introductory so there is not any bible preparation needed for that session. The first short zoom meeting will be on Wednesday, January 22 at 7:00 p.m. Read through session one and watch the video before the zoom session.

SECOND, Ascension Press is beginning a new FREE podcast on Wednesday, January 15 entitled LUKE IN 50 DAYS. "In each episode, Fr. Mike Schmitz will read a section of Luke's Gospel. Jeff Cavins and Scott Powell will provide commentary and insight about the beautiful prose and unique parables." This podcast should be available on most podcast apps.

NOTES: As the Bible study materials will explain, a Catholic bible is needed and a Catechism book. Catholic versions of the bible are online if you don't have one or like to look at several different ones. I checked at the US Catholic Bishops site usccb.org and the actual Catechism at <https://usccb.org/sites/default/files/flipbooks/catechism/>. Zoom sessions will be each Wednesday at 7:00 p.m. through March 19 except for Ash Wednesday. Hope this all makes sense! Basically, everyone will be doing their own study questions and video. We will come together as a zoom group to discuss our answers. Participate when you can. Anyone is welcome.
