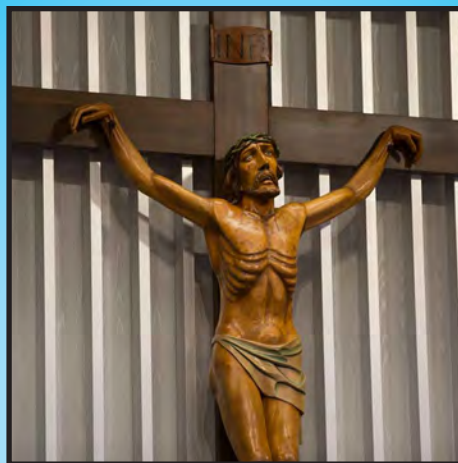

A Message from Fr. Tom Donovan:



QUINCY CATHOLIC
ELEMENTARY SCHOOLS

A little over a week ago, Dr. Chris Gill of Quincy Catholic Elementary Schools (QCES) sent a press release announcing that QCES had received approval of its new by-laws from the Quincy-area pastors and from Bishop Paprocki. This is a significant milestone for our schools effort, but I

sense that there is some uncertainty about what all of this means. Indeed, by-laws and corporate structures and organizational details tend to be rather abstract and aspirational, compared to tangible things like buildings, books, and computers. Further, when there are gaps in understanding, there is a tendency towards gossip and speculation to fill in the gaps, with each iteration of the discussion tending to become further removed from reality. I wanted to take this short space to explain the significance of this event and explain where the Quincy Catholic Schools effort is going from here.

The Quincy Catholic Schools effort traces its roots to the "Leadership Team" that was formed shortly after the school and parish reorganization of 2004. Everyone understands how traumatic those years were, and there was a commitment among the parishes and pastors of the schools to work together for the common benefit of Catholic Education in Quincy. Part of this was driven by the reality that in those early years a foundation had been established, the Quincy Catholic Elementary Schools Foundation, a separate entity with its own board and by-laws as a non-profit 501(c)(3) organization, to provide tuition assistance, and requiring the schools to work together for distribution of those funds and at the same time to provide for common efforts in marketing on part of its director. This job was held for many years by Dr. Paul Rittoff, who had an office at St. Anthony's and did this work, which included public visibility for the Mega Raffle and the annual "Friends of Catholic Education" banquet, but also included the behind-the-scenes work of allotting funding for scholarships to students and families, soliciting gifts and bequests for the foundation, and running the marketing efforts for our four schools, among other things.

This loose association of pastors, principals, laypeople, QND, and QCESF was charged with, among other things, setting the common tuition rate for all of our schools, as had been agreed as a practice flowing from the 'reorganization years'. This tended to be a perennial mess as the needs of each of the schools were different, there was a desire to keep prices down to encourage enrollment, parishes tended to represent their financial position as better than it really was (in order not to have the perception that they were threatened with weakness and closure) and each parish had somewhat different financial needs and accounting practices, making the process a bit opaque and arbitrary. Indeed, each parish and school sometimes had to put the good-faith efforts of this committee in jeopardy, as each parish and school had to act in their own best interests. This would sometimes lead to bitter arguments about tuition rates, our complicated reimbursement plan for when families & students crossed parish lines, and the way that some families would play one school against another in a 'race to the bottom' when standards or expectations for everything from Mass attendance to grading standards to lunchroom menus to sports participation was in question.

Indeed, our own St. Dominic School, I believe, was headed towards a crisis as I arrived in 2016, as our accounting practices were inadequate to show how backwards we had become with our revenue and expenditures cycles. This Leadership Committee did not have the ability to oversee or prevent this decline, just to observe it from afar, leading to the persistent rumors that one or another school in this community was "heading toward closure". There was never anything unethical or missing or anything like that with our accounting... we simply did not have a system that was reporting the information we needed in order to make good management decisions. There is a whole story to tell here, but in the context of this short space, I'll have to save it for later. Suffice it to say, in the years after my arrival, the finance council and school administration took drastic measures to cut expenses and align expenditures with their proper reporting periods (tuition received was spent in the year it was intended, not when it was received!). With an increase in enrollment and other revenues over the course of many years now, we made it through and are in fairly good health right now.

Back to QCS... shortly before COVID, Msgr. Enlow, as dean, gathered the local pastors, recognizing that the health of Quincy Notre Dame High School depended on the health of not only St. Peter's School, but all of our local Catholic Schools. As part of the Leadership Committee, this group regularly reviewed enrollment and financial trends in our schools. We recognized that if even one of our schools were to get into trouble or fail, then the student population at QND might fall to a level which could call into question their ability to carry on as they have done. With a view to keeping QND healthy, the pastors agreed to enter into a study of how we might do a better job of running our schools as a system. We had heard of the Kankakee "Bishop McNamera" Catholic Schools system as a model which had proven a difficult path to follow, but one that was beginning to flourish, despite having declining demographics and the complications not unlike our situation with several distressed small schools coming together to do something... amazing.

From the onset, working through those years, and COVID, the committee continued to meet to explore possibilities for the future, and to get a better handle on our demographics, our finances, our projections, and the core of what we are about as Catholic Schools in the first place, which is that they are a place to "form the next generation of disciples for Jesus Christ". In this we discovered that we had the ability to serve just as many students, increase our offerings, provide for an administrative layer which would take a lot of the administrative burdens off the pastors and principals (which had grown much heavier in recent years as parishes like ours cut down hour and salaries of personnel for the purpose of mere survival), but it would require us to redistribute our students across several schools in the famous (or infamous?) "facilities plan" that was proposed last year. The main source of

A Message from Mrs. Carol Frericks—Principal

Fourth Grade Leaders At Morning Assembly



Our St. Dominic School mission statement claims, that St. Dominic School is a dedicated Catholic school community promoting spiritual growth and academic excellence while challenging students to use their talents to lead and serve. During the month of September, our fourth-grade students had the opportunity to lead and serve our school during our Morning Assemblies. Mrs. Katie O'Neal, fourth-grade teacher, provided the daily Scripture reading and reflection to begin each day with prayer. Then, she provided her students with leadership roles and shared the microphone so her students could lead our students in grades kindergarten through eighth-grade in reciting the Pledge of Allegiance, the birthday celebration song, and the Bible Verse for the 2025-2026 school year, which is Romans 5:5. The fourth-grade class also provided a lesson on the Fruit of the Holy Spirit for this month, which is the fruit of JOY.

our savings would come from optimizing our classroom staffing so that more of our classes were closer to full. This would be facilitated by having all of each grade in one building, rather than spread out across the community. Savings from this reorganization would have put us in the position to expand other services. This proposal was roundly rejected by our community, and thus the facilities plan has been shelved. This is not to say that we will not need to revisit it in the future—all our schools are in old, maintenance-intensive buildings, and the problems of small classes in certain places remains an inefficiency in our current model. While we may need to look at alternatives in the future, but nobody wants to push a proposal that is unacceptable to our families at this time.

During the process of examination and discernment, we transitioned from the old "Leadership Team" to a "board of specified jurisdiction" for these cooperative efforts. What does "specified jurisdiction" mean? Under our current system of parishes and schools, pastors are responsible for the full legal and ecclesial authority to operate each school, with accountability directly to the bishop. As we continued our studies, this "board of specified jurisdiction" was formed under the supervision of the bishop and the pastors as a lay board who could assume certain responsibilities delegated to them in the 'jurisdictional' acts of governing and operating the schools. The terms of this overarching organization are rather loose, meaning that there could be a great amount of authority given over where we would suppress our schools as independent entities and let the board do everything, OR less authority could be given, where the schools maintain their independence from each other, but we agree to work together in certain, limited areas. We have taken the second of these two paths, keeping our schools independent, but committed to working together. The board who has been seated to do this work is now formally coming into legal and canonical existence in their own right as more than an advisory board.

The pastors, at the advice of their Pastoral and Finance Councils and School Boards have decided to be narrow and specific about the tasks to be entrusted to a system of common governance and oversight: The place where we need the most help right now is in the business operations of our schools. Most of our pastors do not have formal business training. They have very good practical experience from running their parishes and the support provided by the diocese and by lay advisors, but the business part of running parishes is not why we got into being priests. By working together with a 'central office', we hope to be able to efficiently deliver the business functions that are necessary to run a modern school. Principals will no longer need to be responsible for entering and monitoring tuition charges, payroll and human resources services that are presently duplicated in each parish can be centralized into one office, budgeting can be done in a way that does not encourage parishes to be less-than-forthright about difficulties they may be in, payables out of all the schools can be collected in one business office which can manage contracts and agreements about copiers, trash, lunches, supplies, maintenance, and so on. We all know that a century ago, under the diligent ministry of our religious sisters all of this was not necessary, but we don't live in those simple days anymore. (Believe it or not, back a century ago, it wasn't actually that 'simple', either!) In short, by standing up QCES, we will have an infrastructure to which we can entrust the work of helping manage these aspects of our schools. Most of the work now will be "behind-the-scenes"... not hidden, just working quietly in the background, not attracting visibility or interest. These are the nuts-and-bolts details of daily business processes that, when they are working correctly, can be simply taken for granted.

One of the frequent questions that is asked is, how is adding a layer of administration going to save us money? Simply stated, it is not. Reorganizing the facilities would have saved us money to allow us to redistribute resources, but the system we are putting into place right now does not. In many ways, what we are doing now simply restores some of the business capability which has been given up by not hiring positions, especially at St. Anthony and St. Dominic, in recent years to keep the school afloat. Locally, Carol Frericks does a lot of work which is not on the job description for principal and I as pastor am doing a lot of business work that I should lay aside in favor of priestly work. I need to get the pastor's responsibilities for the business aspects of our school under control for that someday when a successor comes in who likely does not have that aptitude or know-how to do these business functions. I do not want us to lose the massive gains we have made in recent years, nor do I want to burn out my successor with the expectation of being able to do this kind of work routinely.

The hard part is now going to be the next step, which is devising the actual "participation agreement", which will outline the specific tasks that will be delegated to QCES from the participating parishes and how the parishes will fund this work. This is going to be a most difficult process of discernment, trust, and cooperation among the pastors and the 'board of specified jurisdiction'. We will do our best to keep you informed of the progress of these negotiations and what that will mean for our school communities. Keep asking the good questions of me and the QCES team. It is my hope and expectation that the hard work we have been doing over more than six years will bear fruit to keep our schools stable and healthy. The important part is that these efforts should not change how we deliver education and minister to families through the work of our dedicated teachers and school staff. That is what our system is known for and what we are all trying to preserve for future generations of disciples.

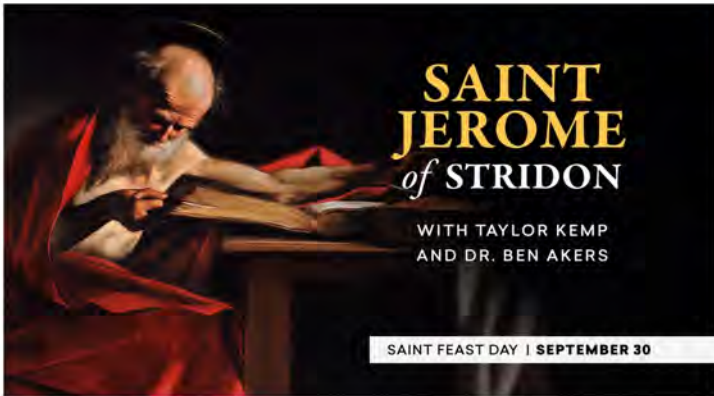
Come Pray the Rosary with Us!
